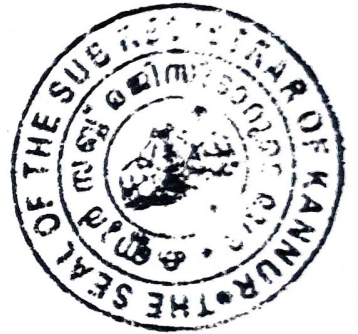

(Sd) Abdul Kadher M K, 2. (Sd) K V Rasheed 3 NOW THIS DEED WITNESSED AND DO HEREBY DECLARE AS FOLLOWS: I Name of Trust: This Trust shall be called as Global India Educational and Charitable Trust. II Registered Office: The registered Office of the Trust at present shall be at Building No: 1613 G 8, M 2 H Plaza, Payancheri Mukku, P O Iritty, Kannur 670703. Board of Trustees shall be at liberty to shift the registered office to any other places when the circumstances arise. III Transfer: We do hereby grant, contribute ₹ 10,000/ (Rupees Ten Thousand only) in the Trust and transfer the said amount to the trustees mentioned herein above with and subject to the right and power herein after expressly stated. 1. (Sd) Abdul Kadher M K, 2. (Sd) K V Rasheed 4 IV AREA OF OPERATION The area of operation of the Trust shall be the Kannur in particular, territory of India in general. The trust may start any branches, extensions or institutions in any foreign country and / or may enter into any collaboration, adjustments or understandings with any foreign institutions as permitted by the Indian law. V OBJECTS OF THE TRUST: (A): (1) To establish, takeover, commence and maintain educational institutions including State and C B S E syllabus schools, Technical intuitions, professional colleges, Science and Arts colleges, Industrial Training Centers, Orphanage, Centers for handicapped and mentally retarded, Old age House, Management institutes, Library and reading rooms, Cultural centers in all over India and to manage, expand and improve and generally to act for the advancement of such educational institution. (2) To establish, take over, start and maintain institutions intended for educational, cultural, moral, economic and social welfare and advancement and for the physical well being of the people. (3) To start, maintain and manage hostels, reading rooms, social and education centers, clubs, Arts and crafts centers and institutions for the recreation activities for the welfare of the students. (4) To establish and maintain educational institutions for children such as Nurserv schools, Inland health centers, cultural and educational centers for the children, children's Library, Hobby clubs, etc. (5) To promote education by providing facilities of scholarships to deserving students studying in the institutions of the Trust in such manner as may from time to time be deemed proper by the governing body of the Trust. (6) To extend financial assistance to the poor and needy bright students with preference to those weaker, backward and minority section of
